(SAPICA)
Including listing on www.ImageSouthAfrica.co.za**

This contract endures for an initial fixed period of 12(twelve) months with effect from date of publication and shall subsequently be automatically renewed for 12 month fixed periods thereafter. The member must give notice of termination in writing 3 months prior to the renewal of the contract each year.

1. SAPICA, agrees to provide, and the member agrees to accept, advertising space on the SAPICA website. www.ImageSouthAfrica.co.za
2. SAPICA shall create and supply an advertisement for display on the website in keeping with the professional standard of the site and standard search engine friendly requirements. A sample template of the requirements is available on payment of membership fee.
3. The member shall deliver to SAPICA the relevant copy details; a professional head and shoulders photograph and company logo in electronic form only. Copy will be accepted up to an A4 size and the logo and photograph of the member must be scanned at 72dpi. Please include all contact details that you would like displayed on your page on the website.
4. Once the member has submitted the document, and it has been published on the site, no changes will be accepted unless paid for by the member at a fee to be discussed with the secretary.
5. No abuse of membership or misrepresentation of the SAPICA logo will be tolerated. The SAPICA reserves the right to terminate a member's membership should this come to our attention.
6. The membership costs are as follows:
-The initial fee of R600-is a once off annual payment and is non-refundable. This fee includes the set up of your advertisement on the SAPICA website. The registration fee is due to initiate design.
